NOTIFICATION

In pursuance of Sankalp No.-15/A2-01/2014-1594 dated- 20.08.2014 and Memo No.-15/A2-01/2014-925 dated-13.04.2021 of Education Department, Government of Bihar, Patna, Advertisement for engagement of Guest / Part Time Teacher was published by the University in newspapers and uploaded on the University website vide Advertisement No.- PUP-GT-001/2025, dated- 14.08.2025. The candidates found eligible were interviewed in the meeting of Selection Committee held on **27.11.2025** for the Subject **Psychology**. On the recommendation of the Selection Committee and subsequent decision and approval by the Syndicate vide **Agenda No. 05**, in its meeting held on **17.01.2026**, the following persons are hereby engaged as Guest/ Part Time Teachers in **Psychology** purely on temporary basis on a fixed honorarium of Rs. 1,500/- (Fifteen Hundred Only) per class with the maximum 50,000/- (Fifty Thousand Only) in a month. They will get their honorarium when the University receives grant from State Government in this head. However, the benefits of Provident fund, EPF, Pension, etc., shall not be admissible to Guest/ Part Time Teachers.

The tenure of engagement of Guest/ Part Time Teachers will be for the period of 11 months or till the regular appointment of teacher made by the Bihar State University Service Commission, whichever is earlier. The engagement of Guest / Part Time Teachers will be automatically terminated after completion of 11 months. Their services can be terminated at any point of time by the University with notice period of 10 days. In future, they will have no claim for permanent job/ absorption on the basis of this engagement. In the case of any discrepancy/ irregularity/ illegality is detected at any stage, the service of the concerned person/ persons will be terminated.

Selected Candidates are directed to submit their joining reports to the Principals/Prof. in-charge of the College mentioned against their names latest by **1st Week of February 2026**. They are also directed to submit the affidavit issued by First Class Magistrate at the time of joining stating "**in case of any discrepancies/irregularity/illegality detected at any stage regarding their educational qualifications, experience certificate/ caste certificate/ medical certificate and all related documents, their engagement as Guest / Part Time Teacher shall be terminated forthwith.**"

No T.A./D.A. is admissible for joining.

The present engagement of the aforementioned candidates shall be subject to following terms and conditions: -

01. The University reserves the right to terminate the teachers who will be found to violate the service code of conduct or if any disciplinary actions are contemplated against them.
02. It is a purely temporary engagement which may be terminated on receipt of panel/recommendation for appointment of regular Faculty/ Teachers from B.S.U.S.C., Patna and as per the requirement of University subject to the availability of vacancy in a particular subject. The sequence of termination will be based on the combined merit list from bottom in concerned subject as per availability and requirement.
03. The selected candidates must not be convicted in any criminal offence and also no disciplinary proceedings should be pending against him/her. (Separate affidavit is needed).
04. They will be paid their remuneration/honorarium only on receipt of grants for them from Education Department, Government of Bihar.
05. In case of unsatisfactory performance of a candidate, his/her engagement can be terminated by the University with 10 (ten) days' notice.
