Sir/Madam,

The Governor's Secretariat, Bihar, Lok Bhawan, Patna, vide Notification No. BSU (Regl.)-05/2010 (Part-1)-1315/GS(I) dated 23.06.2026 and Notification No. L/ORD./02/2026-1412/GS(I) dated 04.07.2026, has notified the **Uniform Ordinance & Regulations (Minimum Standards and Procedure for Award of Ph.D. Degree), 2026**, which have been approved by the Hon'ble Chancellor.

The **Ph.D. Uniform Ordinance & Regulations, 2026** shall supersede the existing *Uniform Ordinance & Regulations governing the Award of Ph.D. Degree by the Universities of Bihar*, promulgated vide Governor's Secretariat Letter No. 2684, dated 21.09.2017, together with all amendments made thereto from time to time.

In pursuance of the aforesaid notifications, all Universities in the State of Bihar have been directed to adopt the said Uniform Ordinance & Regulations, 2026 after obtaining approval from their respective statutory bodies.

Accordingly, the Uniform Ordinance & Regulations, 2026 relating to the "Minimum Standards and Procedure for Award of Ph.D. Degree" have been duly considered, approved, and adopted by the **Academic Council** and the **Syndicate** of Purnea University, Purnia.

Accordingly, it is hereby notified for the information of all Heads of Postgraduate Departments and the Principals/Principals-in-Charge of all Constituent and Affiliated Colleges under Purnea University that the said **Uniform Ordinance & Regulations, 2026** stands adopted by the University.
