Note: The validity of the Certificate / Score Card of NET/CSIR-NET/ GATE or similar national level test qualified eligible candidates will be determined in the following manner:

- i. For admission to the Ph.D. programme in the Academic Year-2024: NET/CSIR-NET/ GATE or similar national level test Score Card/Certificate must be valid on 18.12.2024, i.e., the date of first notification for Pre-Ph.D. Admission Test (PAT) 2024.
- ii. For admission to the Ph.D. programme in the Academic Year-2025: NET/CSIR-NET/ GATE or similar national level test Score Card/Certificate must be valid on 10.02.2026, i.e., the date of notification for admission to the Ph.D. programme in the Academic Year-2025.
