AFFIDAVIT

7. That I shall not claim regularization, permanency, absorption, seniority or appointment against any regular post in Purnea University, the Higher Education Department or the Government of Bihar merely on the basis of this contractual engagement.

8. That I shall not, at any stage, raise any claim before any authority, tribunal or court seeking regularization, permanent appointment or service benefits admissible to regular employees solely on the basis of this contractual appointment.

9. That I undertake to abide by all the provisions of the Bihar State Universities Act, the Statutes, Ordinances, Regulations, Service Conditions, Government Notifications and the Rules, Regulations and Orders issued by Purnea University, Purnia from time to time.

10. That I further undertake to immediately inform the University in writing if any criminal case, disciplinary proceeding or any other material fact affecting my eligibility comes to my knowledge after submission of this affidavit.
