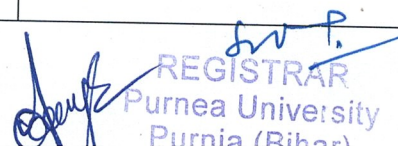

TERMS AND CONDITIONS / JOINING INSTRUCTIONS:

1. The appointment is purely contractual and shall be governed by the applicable Statutes/Ordinances, recruitment notification and orders of the Competent Authority. 2. Each appointee shall join at the allotted place of posting latest by 18.08.2026. No extension of joining time shall be afforded to the candidates. Failure to join within the stipulated period shall result in cancellation/forfeiture of the appointment.
3. At the time of joining, the appointee shall submit the joining report to the Principal/Head of the allotted institution along with originals and self-attested copies of all required certificates/documents.
4. If an appointee is presently enrolled/registered in a Ph.D. programme or any other regular/full-time course incompatible with the duties of this appointment, he/she shall mandatorily submit a duly sworn and notarised affidavit regarding discontinuation/withdrawal from such course and proof thereof, wherever applicable.
5. If an appointee is presently employed in any Government/University/College/PSU/private institution or any other organisation, he/she shall submit a No Objection Certificate (NOC) from the present employer and, wherever applicable, a relieving order/acceptance of resignation before joining.
6. The University shall remain competent to conduct further/post-joining verification of certificates, documents, testimonials and information furnished by the appointee.
